





Hello Friend,

The Prescott Creekside E-News that you received on the 6<sup>th</sup> of March did not anticipate the sweeping changes that the COVID-19 crisis has brought to our world in the past two weeks. We'd like to share with you the strategy Prescott Creeks has in place for the duration of this crisis.



## **Overall Strategy**

Prescott Creeks is following guidance from the **Center** for Disease Control. Specifically guidance issued on Sunday 15 March has been implemented with the cancellation or rescheduling of group gatherings. The Prescott Creeks staff is working from home where practicable and all in-office or group volunteer activities have been suspended until further notice. The Prescott Creeks office will remain open by appointment only. We will continue to monitor the COVID-19 developments and guidance and adapt our procedures and strategy as appropriate.

Throughout this crisis Prescott Creeks intends to continue pursuit its mission to achieve healthy watersheds and clean waters in central Arizona for the benefit of people and wildlife through protection, restoration, education, and advocacy.

As people are largely staying at home, Prescott Creeks will be working on increasing our social media and online presence with project updates, success stories, and other mission related information.

#### **Press Event**



The Press Event originally scheduled for 1pm on March 19th (today) has been indefinitely cancelled. The intent of this event was to discuss the importance of the Miller Creek Public Restroom to surface water quality and the community. With major funding from the Arizona Department of Environmental Quality, this project represents an innovative approach to water quality improvement involving a diverse group of partners.

### Volunteerism

As noted in the Overall Strategy to the left, all in-office or group volunteer activities have been suspended until further notice.

That being said, there are still oppotunities for volunteerism with Prescott Creeks if you are interested to help during the COVID-19 crisis. Several volunteers have agreed to assist with data entry by working

the lease and establish a conservation easement for Watson Woods Riparian Preserve. Finalizing ecological restoration plans will set the stage for on-the-ground work to begin as soon as winter 2020/2021.

### Granite Creek Cleanup to be Rescheduled

Due to concerns about COVID-19, Prescott Creeks is rescheduling the Granite Creek Cleanup originally set for April 18<sup>th</sup>, 2020. Pending developments with the COVID-19 crisis, Prescott Creeks will coordinate with its partners (City of Prescott, Butte Creek Restoration Council, and Over the Hill Gang) to reschedule this event and provide notification to the public. Thank you for your understanding.



Generous support from committed sponsors will carry forward to the rescheduled event. While the Cleanup represents an important community and civic engagement activity, Prescott Creeks believes that exercising extreme caution and following CDC recommendations is the best course of action at this uncertain time.
